REASON(S) FOR AMENDMENT

This cooperative agreement is amended to approve a revised billing timeline which will provide additional advance notice to .edu registrants of impending invoice due dates (double from thirty to sixty days the date of the initial e-mail reminder of the annual invoice, and to e-mail another reminder thirty days from the due date, instead of on the due date for unpaid invoices). In addition, EDUCAUSE desires to e-mail a reminder to a registrant's three domain name contacts when the registrant has paid its invoice, but failed to execute the Customer Service Agreement 60 days after the agreement's due date. Approval is also given to revise paragraph 3 of the Customer Service Agreement to: (1) clarify that EDUCAUSE is authorized to charge an annual domain registration fee; and (2) substitute the existing five-year registration term with a one year term to comport with the annual billing cycle.

This Amendment approved by the Grants Officer is issued in triplicate and constitutes an obligation of Federal funding. The revision would replace the first three sentences of the existing contract with:

3. FEES AND TERM OF SERVICE. As approved by the U.S. Department of Commerce, EDUCAUSE charges an annual fee to recover costs for domain name registration services. Details of the current fee and payment terms are found on our Web site. Unless otherwise specified, each domain name registration is for a one year initial term and renewable in perpetuity thereafter for successive one year terms, as specified during the renewal process.

EDUCAUSE will also add "technical, and billing" to the administrative contacts it may public in the .edu WHOIS database described in paragraph 4 of the Customer Service Agreement.
